1. Call to Order/Roll Call

4. Census Impact to Current Approved Map

Mr. Wheeler Spoke regarding the census impact.

Mr. Skimerhorn spoke about the mapping process and the software updates associated with the new census numbers. The new census numbers caused deviations as high as 27% with the map that was approved.

Mr. Wheeler and Mr. Skimerhorn presented the map that was approved in June with the new census numbers. Deviations were discussed.

Mr. Hess commented on the loss of people in Kankakee and the number of districts in Kankakee.

5. Elimination or Adoption of Proposed map: Map 2021-Balanced

Mr. Wheeler presented Map 2021-Balanced to the committee. Printed maps were distributed to the committee as well as electronic versions.

The highest deviation was 4.6% and the map was reviewed by the State's Attorney's Office.
